



## LEGISLATIVE UPDATE

## FSPA's 2024 Legislative Agenda takes shape

F S P A is already gearing up for the 2024 Florida Legislative Session and is preparing to take on some long overdue revisions in the Florida Statutes. FSPA is working

with legislators in the Florida House and Senate to file a swimming pool contracting bill package that will touch three areas of law that, when passed, will be a great benefit to the Florida swimming pool and spa industry and the consumers the industry serves.

### Scope of Work Revision

The main thrust of the bill FSPA is working on for 2024 is a revision and clarification of the scopes of work for the three primary swimming pool and spa contractor's licenses. It has been more than 30 years since these scopes of work have been revised and clarified.

The FSPA's Scope of Work Taskforce has spent the past several years painstakingly creating a draft revision of the scopes of work that preserves the current scope of work, clarifies and modernizes the terms used, and clarifies specific aspects of the scope of work where there have been conflicts with building departments in the past. The revision language does not expand or shrink the scope of work for swimming pool and spa contractors but draws on modern industry language and practice, declaratory statements, and current CILB rules to ensure that the scopes of work in the Florida Statutes accurately reflect the work Florida swimming pool and spa contractors are qualified to perform. Some of the revisions include clarifications of a swimming pool and spa contractor's pool electrical and bonding scope of work (a codification of CILB rules), retaining walls, fountains, swimming pool decking, concrete

footings, and more.

## General Contractor's Swimming Pool Scope Clarification

Under Florida Statutes Sec. 489.113(3)(c), a general contractor has a narrow exception to perform structural swimming pool work, but the statute specifies that all other swimming pool work on that pool must be performed by a swimming pool and spa contractor. This exception is further clarified by CILB Declaratory Statement DS2014-041 which holds that a general contractor cannot qualify a company to build swimming pools or advertise themselves as a swimming pool and spa contractor.

FSPA is seeking to codify this Declaratory Statement and put it into statute that a Florida general contractor cannot hold themselves out as swimming pool builder. Making this clarification will help Florida Building Officials and local

## **DIGGING UP IDEAS**

## Can I build that?

As Florida licensed pool contractors, we know what work our contractor's license allows us to do within our scope of work. But, there can be a disconnect between work that unlicensed

contractors are capable of performing and what Florida Building Code allows to be performed legally.

Often homeowners do lots of research online which can lead them to conflicting information, and downright false information, about building permits and what type of work can be performed. Hiring practices that are legal in some states may not be legal in Florida, and often advice given to Florida homeowners does not take the location of the project into account. Sometimes unscrupulous contractors will intentionally try to get homeowners to pull Owner Builder permits for work they are not licensed to perform.

This article is intended to cover the licensing requirements under Florida law when working on a swimming pool. The specific focus is on residential swimming pool construction in Florida. Additional, or different, licensing may be needed for commercial swimming pool construction, renovation work, or service and maintenance work.

In Florida, a Certified Pool Contractor is identified by a license number that begins with CPC followed by 7 numbers, i.e.: CPCxxxxxx. A swimming pool contractor who carries a CPC license can work anywhere in Florida and is not limited by geography. There are also Registered Pool Contractors. The difference is, the Registered Pool Contractor is geographically limited and can only work in a county in which they are registered. A Registered Pool Contractor license will begin with "RP" and will typically be RP followed by numbers i.e.: RPxxxxxx.

The CPC and RP license designations are given to the three primary swimming pool and spa contractor licenses:

**Commercial Swimming Pool/ Spa Contractor:** Building, repair, and remodel/resurfacing of any public/ commercial or private swimming pool or spa. Installation, repair, and replacement of public/commercial and private swimming pool and spa equipment and piping.

Residential Swimming Pool/ Spa Contractor: Building, repair, and remodel/resurfacing of residential swimming pools and spas. Repair, and remodel/resurfacing of public/ commercial swimming pools and spas. Repair, and replacement of public/ commercial and private swimming pool and spa equipment and piping.

## DOH change to test kits and free chlorine

Recently, the Florida DOH made changes to the types of test kits and the maximum free chlorine and b r o m i n e allowed in spa pools. This change

is now 5 PPM for free available chlorine and 6 PPM for bromine residual.

In addition, there are important changes in the types of testing kits allowed to be used on both pools and spas throughout the state. Whatever the brand of test kit you or your customers use, it must now meet NSF Standard 50-2020 Level 1 accuracy certification. Without naming types of brands, the current test kit most of us use does not meet that certification.

It is important for both service companies and properties to ensure that the proper test kit is on site, and on our vehicles. As we all know, the proper test kit is number 21 on an inspection test kit, and while a pool may or may not be immediately closed, it will be cited at a minimum. This rule is in effect now, and you can expect every inspection and sanitarian to be on the lookout for this.

It is also important to note that most of the electronic kits, such as Palin, already meet this criterion. While the Taylor K2005, which has been the standard of the industry for so long, does not meet the requirement, Taylor does have other kits that do meet this new criterion. My suggestion is to contact the manufacturer, or your supplier, for further

guidance on the kit you carry and provide.

As always, best of luck, and please let me know if you need any further clarification.

Dear Public Pool Owner and/or Public Pool Operator:

The Florida Department of Health (Department) revised Rule 64E-9.004, of the Florida Administrative Code, effective June 11, 2023. Among other changes, the Department revised the provisions related to the level of disinfectants permitted by the rule and the test kits approved for use. We are providing this notification to you as a courtesy, as these changes may affect the current operation of your pool(s) and/or spa(s).

#### Summary of the disinfectant revisions:

- a. The maximum free Chlorine residual is now 5 ppm (mg/L) for spa-type pools.
- b. The maximum available Bromine residual is now 6 ppm (mg/L) for all pools and spas.
- c. There were no changes for the minimum level of disinfectants that are allowed by the rule.
- d. There were no changes for the maximum level of Chlorine in most pools (except spa-type pools).

If your pool or spa is higher than these residuals, the pools or spa must be immediately closed to patrons until the residual meets the rule standards.

Rule 64E-9.004(1)(d)2.: Disinfection – Free chlorine residual shall be as follows: 1 milligram per liter (mg/L) to a maximum of 10.0 mg/L, inclusive, in conventional swimming pools; 2 mg/L to 10.0 mg/L, inclusive, in all other type pools such as swim-up bars, wading pools, special purpose pools, water recreation attraction pools, and interactive water fountains; and 2 mg/L to 5 mg/L, inclusive, in spa-type pools; or available bromine residual shall be 1.5 mg/L to 6 mg/L, inclusive, in conventional swimming pools and 3 mg/L to 6 mg/L, inclusive, in all other type pools. Except that, for indoor conventional swimming pools, the maximum disinfectant residual shall be 5 mg/L free chlorine and 6 mg/L free bromine.

#### Summary of the test kit (water quality test device) revision:

a. NSF Standard 50-2020 Level 1 accuracy certification required for disinfectant test kits.

If you do not have this type of test kit at the next inspection, the Department staff will cite your pool for the violation and requires you to acquire this type of test kit by the next routine inspection.

Rule 64E-9.004(10): Test kits are required to be on the premises of all pools to determine free active chlorine and total chlorine using N, N-Diethyl-p-Phenylenediamine (DPD), or available bromine level, total alkalinity, calcium hardness, and pH. NSF/ANSI/CAN Standard 50-2020 level 1 accuracy-certified water quality test devices/kits or specific laboratory analysis methods identified by the chemical product manufacturer must be available to determine the concentration in pool water of all NSF/ANSI/CAN Standard 60-2021 approved chemicals that are fed or added to a public pool, or the chemical cannot be used. NSF/ANSI/CAN Standard 50-2020, Equipment and Chemicals for Swimming Pools, Spas, Hot Tubs and Other Recreational Water Facilities, October 21, 2020, is hereby incorporated by reference, has been deemed copyright protected, and is available for review at the Department of Health, Bureau of Environmental Health, 4025 Esplanade Way, Tallahassee, Florida 32311 or at the Department of State, R.A. Gray Building, 500 South Bronough Street, Tallahassee, Florida 3239- 0250.

authorities to enforce Florida contracting rules for general contractors who are practicing outside of their scope of work by advertising that they can build complete pools, which is outside of the narrow exception that is granted to them under the Florida Statutes.

### Florida Construction Recovery Fund

As you may know, a small portion of every building permit fee paid in Florida is set aside in what is know as the "Construction Recovery Fund" (the Fund) that is administered by the Construction Industry Licensing Board (CILB). The Fund is available to Florida consumers monetarily damaged by a Florida contractor; consumers can apply to receive funds to help make them whole based on court judgment, arbitration award, or award by the CILB. Currently, consumers' awards are capped at \$15,000 for all Division II contractors, including swimming pool and spa contractors. Given the nearly 40% increase in the cost of swimming pool and spa construction over the past few years, the \$15,000 cap does not give the CILB much room to help a consumer who is damaged by a swimming pool contractor. To help address this issue and make more funds available for consumers, FSPA is pursuing a statute change that would raise the cap for customers of swimming pool and spa contractors from \$15,000 to \$50,000. This change will give the CILB more leeway to help consumers who have been damaged. This change will not increase building permit fees.

These three changes to the Florida Statutes are long overdue and will be of great benefit to the swimming pool and spa industry and all Floridians who interact with the industry. Once the bill has been filed and the language has gone through the legislative drafting process, the bill language will be made available to all FSPA members. FSPA is excited for a very positive and productive 2024 legislative session where the association can continue to build on a reputation of getting legislative wins for the Florida swimming pool and spa industry.

## Insurance liability risks of servicing commercial pools

Over the past few years insurance claims for alleged injuries and incidents arising from a claimant's use of a commercial swimming pool or spa have increased signific antly

in number, in scope, and in monetary demands.

These claims are addressed by the General Liability policy under the Bodily Injury coverage section. Attorneys have always tried to hold the pool contractor responsible for essentially everything to do with the pool (and surrounding pool area) and they have been getting some traction with jury awards and threats of sky-high lawsuits. When there are drownings and/or near drownings, the threats become more meaningful. What jury isn't going to do all they can to find a way to compensate a family for a loss such as this? We also see our fair share of slip and fall allegations as well as even allegedly causing Legionnaires Disease.

We see these filed claims (and demand

letters from the attorneys that follow) daily. The service technician is generally at a commercial pool only 3-4 times a week for a short period of time and yet the service company is seemingly held responsible as if they are fulltime 24-7 attendants at the pool and premises. And, it's not just related to pool water chemistry. Not by a long shot.

If the gate to the pool has a broken or failing latch or doesn't close properly and you don't put the property owner on notice – it's your fault because you failed to act in the capacity of your perceived responsibility. That's what the lawyers all say. Same with lifesaving equipment like a buoy and shepherds hook (or any safety equipment). Hole in the fence, no depth markings or markings not to code - that's your fault, too if you don't notify the pool owner/manager.

Use your imagination and I'm sure you can come up with other examples too. And, after the fact, the property owners and managers are first in line to place both responsibility and blame on the pool service company. How? Because they state that they rely on the pool service company to be responsible for everything. Or, at the very least, to make them aware of any and

Below is an outline with ideas, concerns, and suggestions. Commercial pools generate decent income, so it is often worth it to take them on as customers. It is, however, to your advantage to have systems and procedures in place to reduce and control your liability and to proactively close the door on opportunities for attorneys to drag you into these claims.

#### Types of Commercial Pools

 Apartment, condo, hoa, hotel/motel/ resort, mobile home park, school, aquatic facility, etc.

#### Associated Risks

- High traffic (slip/trip/fall)
- Unsupervised (drowning/near drowning)
- Easily accessible 24-7 (drowning/near drowning)
- Heavy usage (tough to maintain chemical balance)
- Unsafe community/neighborhood, pool or general pool area
- · Code and Health Dept. violations

#### Challenges of these Pools

- Only onsite 3-4 times per week
- Ongoing service and safety on "off" days
- Assumed responsibility for maintaining safe premises (pool, pool premises, fence/lock/latch, etc.)
- Assumed liability through Contractual (Insurance requirements of Compliance Depot, etc...)
- Acts of both commission and omission
- Required pool water testing (health department) on "off" days

### Suggestions/Considerations

- Preview/Assessment (file documentation) for new commercial pools
  - o Have a written assessment form incl photos for your file
  - o Note the current condition of pool, pool deck, and contiguous premises

- Include safety rules/equipment, fence/gates/ latches/locks, ladders, lights, drains/gutters, lifts/ ADA deficiencies, etc.
- o Document existing problems and issues in writing
- o Inform customer of concerns in writing
- o Determine pool usage (light/heavy, days and time of day) to set schedule for service and pool chemicals
- o Pool: indoor or outdoor?
- o Kiddie pool? What additional concerns does this have?
- o What is the poolside alcoholic beverage policy?
- Questions to consider before signing an agreement:
  - o Is the customer potentially a good partner?
  - o Are there any documented (or obvious) Health Department issues?
  - o Will the customer take action to correct issues and problems?
  - o Will the customer continue to test water on "off" days?
  - o If so, what is their procedure? Do they also balance chemicals?
  - Environment (can pool and pool area be maintained safely?)
  - o Are there any undesirable or unfixable exposures?
- Ongoing Service
  - o Note the current condition of pool, pool deck, and contiguous premises
    - Include safety rules/equipment, fence/gates/ latches/locks, ladders, lights, drains/gutters, lifts/ ADA deficiencies, etc.
  - o Document existing problems and issues (with photos) in writing
  - o Inform customer of concerns in writing (every time)
  - o Are there any undesirable or unfixable exposures?
  - o Has, and will, the customer take action to correct issues and problems?
  - o Is the customer continuing to test water and service pool on "off" days?

CYA suggestion: Recommend a more frequent service schedule (and document it in writing). Always document any life safety issues – every time you go to the property and until they are addressed.

The more liability assumed through contracts (often with property managers or their vendors) the more responsible you are and the more critical it is that you CYA and make sure you have a "good" partner in the owner/manager. The pools and properties which are poorly managed and operated is where 90% of your problems will come from. Try to avoid those properties whenever possible.

In closing, documentation rules the day! Document everything. There's a saying when it comes to trials and litigation, that if something (a discussion, phone call, anything etc.) is not documented in writing... it never happened.

## Can I build that?

of public/commercial and residential swimming pool and spa equipment and piping. Repair and resurfacing of public/ commercial and residential swimming pools and spas.

General Contractor - A General Contractor is defined by a contractors license that begins with CGC followed by seven numbers. ie: CGCxxxxxx. On the DBPR website, it states, "A General Contractor means a contractor whose services are unlimited as to the type of work which he or she may do." But this is inaccurate, or at least misleading! Under Florida Statutes Sec. 489.113(3)(c) a CGC contractor has a limited exception to perform structural swimming pool work only, with all other aspects of construction completed by a swimming pool and spa contractor. When a CGC contractor pulls a swimming pool permit, on the permit they must list a CPC or RP licensed pool contractor as a subcontractor on all aspects of swimming pool phases regulated by swimming pool building code. CGC contractors also cannot qualify a business to build swimming pools and spas or advertise themselves as swimming pool contractors (CILB DS2014-044). This exception for CGC contractors to perform structural swimming pool work is properly used when a pool is being built in conjunction to another building, either a residential home or a commercial project.

Homeowner Permit - As property owner in the State of Florida. homeowners are authorized to act as their own contractor when improving or modifying their property. But there are limitations on who a homeowner can hire as a subcontractor for their projects. When a homeowner in Florida pulls a homeowner swimming pool permit, or an Owner Builder permit, by law they are required to perform all work on the permitted pool personally. Under a homeowner permit, the homeowner is legally and financially responsible for the pool in every way. The homeowner can hire a licensed contractor to perform specific phases of the project, but only if the hired contractor is a licensed swimming pool and spa contractor (CPC or RP) and the work that they are contracted to perform is within their scope of work.

Homeowners CAN NOT hire

unlicensed subcontractors or individuals licensed as Swimming Pool and Spa Specialty Subcontractors! This is very specific in Florida law. Florida Statute 489.103 specifically regulates exemptions to Florida licensing requirements. Subsection 7 specifically provides the legal requirements and responsibilities of owners acting as their own contractor. Homeowners applying for an Owner Builder Permit must sign and notarize a disclosure statement. Among other things, this disclosure statement says: "I understand that I may not hire an unlicensed person to act as my contractor or to supervise persons working on my residence." This disclosure also says: "Any person working on my building must be employed by me, which means that I must comply with laws requiring the withholding of federal income tax and social security contributions and I must provide workers' compensation for the employee."

To put this in plain language, as per the signed and notarized disclosure statement on the Homeowner Permit, any person that is paid any money by the homeowner for work on the pool MUST either have a contractor's license or be an W2 employee of the homeowner.

An Owner Builder CAN NOT hire an unlicensed subcontractor, Swimming Pool and Spa Specialty Subcontractors, General Contractors, or any other contractor. There is no exception under Florida law that would allow an Owner Builder to hire anyone but a properly licensed swimming pool and spa contractor to act as their subcontractor.


